With the passage of the MN Free School Meals Program, each enrolled student will be able to receive one free eligible* breakfast and one free eligible* lunch each academic school day. Second meals, second entrees, milk and A la Carte items may still be purchased as long as the student has either funds in their account or has cash at the time of purchase.

You will need to email foodservice@farmington.k12.mn.us to request a family key to set-up up your account.

When submitting your email request for a family key, please provide your name, the name(s) of your students, and your current address

You will then receive and email response that will provide instructions on how to proceed

We highly recommend setting up your family meal account to monitor account activity and check your balance

If you have already created a family Wordware account, there is NO need to do so again.
